## Judicial Bonds

Court bonds for attorneys and their clients who are involved in litigation. The bond guarantees principals will successfully prosecute litigation and reimburse adverse parties if there are damages resulting from the litigation or satisfaction of a judgment. Bond types include attachment bonds, garnishment bonds, replevin bonds, costs bonds, release of lien, garnishment or attachment bonds and appeal bonds.

Fiduciary bonds are required of attorneys or their clients when appointed by the court to administer the estate or affairs of another who is legally incapable or unable to do so. The bond guarantees the person appointed to a position of trust will faithfully perform all associated duties and account for the property being handled on behalf of others. Bond types include administrator bonds, executor bonds, trustee bonds and guardian bonds.

## Public official bonds

Public official bonds guarantee the faithful performance of duties and/or accountability for handling public funds by various officials, deputy officials, employees and agents of states, counties, municipalities or other political subdivisions or bodies.

## Schedule of special discretionary authority

Actual dollar amounts are negotiable depending upon experience and skill levels in the commercial surety lines.

## General indemnity agreement (GIA)

For customers who need multiple bonds for themselves or others for whom they indemnify.

## Letter of credit form

We will accept a letter of credit from an acceptable bank as collateral to support execution of certain court bonds.
